

AN ORDINANCE TO AMEND THE CITY OF BROWN CITY CODE BY ADDING A NEW SECTION WHICH NEW SECTION SHALL BE KNOWN AS SECTION 17.550 OF CHAPTER 17, ARTICLE 2 OF SAID CODE.

THE CITY OF BROWN CITY ORDAINS:

Section 17.550. Transfer of Interest in Real Property.

An Ordinance authorizing the Brown City Library Board to lease/purchase a certain parcel of real property owned by Tri-County Bank.

Section 17.550.1.: The City of Brown City hereby determines that it is in the best interests of the City to authorize the Brown City Library Board to lease/purchase a certain parcel of real property more particularly described as:

**SECTION 18, T9N, R13E, BROWNS DIVISION OF BROWN CITY SOUTH ½ OF LOT 1 AND LOT 2 SOUTH OF RAILROAD, LOTS 3 AND 9 BLOCK 3..**

The Mayor AND City Clerk are hereby authorized to execute said grant of authority to the library board on behalf of the City of Brown City.

Section 17.550.2 Effective Date: This Ordinance shall take effect immediately after adoption.

INTRODUCTION:

This Ordinance was introduced by Councilmember Christine Lee on October 28<sup>th</sup>, 2019 during a Regular Meeting of the Brown City Council. The Public Hearing thereon was held on November 11<sup>th</sup>, 2019.

MOTION AND VOTE:

Moved by Councilmember Christine Lee, second by Councilmember Patricia Jacobson, to adopt Ordinance 17.550: An Ordinance authorizing the Brown City Library Board to lease/purchase a certain parcel of real property owned by Tri-County Bank. There followed a Roll Call Vote with six (6) Councilmembers present: CM Biel-abstain, CM Jacobson- yes, CM Lee-yes, CM McIvor-yes, CM Navock-yes, CM Robison-yes.
