VACATION BUY-BACK / EXTENSION ADJUSTMENT WHEREAS, the City of Brown City is committed to improving the quality of life of employees; and,

A RESOLUTION TO FORMALLY ADOPT GUIDELINES FOR A ONE-TIME

WHEREAS, an exception to the City of Brown City Personnel Policy Manual is required by the City Council to meet this improvement goal; and,

WHEREAS, the Personnel Policy Manual currently allows up to 50% of an employee's unused total annual vacation days as of March 31st to be sold back to the City at straight time wage. The employee also has the option of retaining unused leave for up to 90 days past April 1st but after that time unused vacation will be forfeited; and.

WHEREAS, due to the national COVID-19 emergency, the Governor's Executive Order 2020-21, and the potential for financial hardship, a one-time vacation adjustment allowing 100% of vacation time unused as of March 31, 2020, to be sold to the City is justified; as is an extension beyond the 90 days to September 30th, 2020, for those wishing to use the vacation days instead.

NOW, THEREFORE BE IT RESOLVED, that up to 100% of a City employee's unused total annual vacation days as of March 31, 2020, may be sold back to the City at straight time wage; or employees can use these vacation days prior to September 30, 2020.

The foregoing Resolution was offered on April 27, 2020, by Councilmember Stacy Biel, and seconded by Councilmember Christine Lee. There followed a Roll Call Vote with four (4) Councilmembers present: CM Biel-yes, CM Jacobson- absent, CM Lee-yes, CM McIvor-yes, CM Navock-absent, CM Robison-yes.
