A RESOLUTION TO FORMALLY APPLY FOR ASSISTANCE FROM THE RISK REDUCTION GRANT PROGRAM (RRGP) TO ENHANCE SECURITY AT THE BROWN CITY COMMUNITY PARK

WHEREAS, the City of Brown City and the Brown City Park Board strive to provide the best recreational facilities available to City and Township residents and visitors; and,

WHEREAS, the limited tax base of the City and small size of the millage approved by voters to support the Park limits significant enhancement in a timely manner; and,

WHEREAS, support from the Risk Reduction Grant Program (RRGP) would afford the community with the necessary means to decrease risk to our recreational facilities and significantly improve security,

NOW, THEREFORE BE IT RESOLVED, that the Brown City Park Board hereby authorizes and approves the Risk Reduction Grant Program (RRGP) Application to accomplish the following specific improvements:

- 1) Install a wireless security camera system to help reduce the frequency and scope of future vandalism; and,**
- 2) Provide a means to identify and subsequently apprehend individuals committing illegal acts within the confines of the Brown City Community Park.**
