RESOLUTION TO APPROVE THE NEGOTIATED AGREEMENT BETWEEN THE CITY OF BROWN CITY AND THE INTERNATIONAL UNION OF OPERATING ENGINEERS LOCAL NUMBER 324, AFL-CIO

WHEREAS, the Department of Public Works employees voted to join the International Union of Operating Engineers Local Number 324 on March 4, 2005; and,
