### **A RESOLUTION TO FORMALLY APPLY FOR ASSISTANCE FROM THE MICHIGAN TOWNSHIP PARTICIPATING PLAN (Par Plan) RISK REDUCTION GRANT PROGRAM (RRGP)**

**WHEREAS**, the City of Brown City fully supports the Brown City Police Department's efforts to provide officers with the best equipment possible to ensure the safety and rights of residents and visitors are preserved to the greatest extent possible; and,

**NOW, THEREFORE BE IT RESOLVED THAT** the City Council for the City of Brown City Area hereby authorizes and approves the Par Plan 2015 Risk Reduction Grant Application to accomplish the timely acquisition of a Pro-Vision Solid State In-Car Video System with a DVR-102 SDXC Card Reader for longer storage of audio and video at a cost of approximately \$2,756.00 installed. The City Council has authorized the funds for the 2015 partial purchase of this system in the amount of about \$756.00.
