WHEREAS, the Mayor and City Council are obligated to review and evaluate the City Manager on a regular basis in order to help ensure quality government; and,

WHEREAS, the City Election now takes place in November, and newly elected officials take office in December, the Mayor and City Council should have time to work with the City Manager to best perform a fair and unbiased formal evaluation; and,

WHEREAS, a formal City Council Policy is necessary to accomplish these goals in a uniform manner;

NOW, THEREFORE BE IT RESOLVED, that the Mayor and City Council shall formally evaluate the City Manager prior to September 30th of each year; conduct an informal evaluation using the same methodology not later than February 30th of each year; and direct the City Manager to develop an evaluation policy for City Council Review and Approval.
