A RESOLUTION TO FORMALLY ACCEPT THE SPECIAL ASSISTANCE FOR RURAL COMMUNITIES AND HOUSEHOLDS (SEARCH) GRANT

WHEREAS, the City of Brown City must contract with the United States Department of Agriculture – Rural Development in order to secure a SEARCH Grant to subsidize the cost of a critically important engineering study of the City’s waste water system; and,

WHEREAS, the City of Brown City agrees to make the services of said system available within its capacity to all persons in Grantee's service area without discrimination as to race, color, religion, sex, national origin, age, marital status, or physical or mental handicap (possess capacity to enter into legal contract for services) at reasonable charges, including assessments, taxes, or fees in accordance with a schedule of such charges, whether for one or more classes of service, as may be modified from time to time by USDA-RD. The initial rate schedule must be approved by USDA-RD. Thereafter, USDA-RD may make such modifications to the rate system as long as the rate schedule remains reasonable and nondiscriminatory.
